- Master's Degree in Neurosurgery or in related field. And
- PHD or Fellowship in Neurosurgery or in related field.

Scope of Work:

- 1. Provide the patient with the necessary psychiatric and rehabilitation treatment and provide the patient with information on preventive measures.
- 2. Performing operations on patients requiring specialist and sub-specialist health care
- 3. Document and record patient health information and share it with appropriate personnel.
- 4. Provide information to various parties in order to fulfill legal and professional duties and assist and cooperate in research and investigations conducted in the field of work.
- 5. Prepare legally required medical reports, participate in medical investigations and give expert opinions where required.
- 6. Participate in the planning and implementation of public awareness programs to prevent diseases requiring health care within the sub-specialty and to do Autopsy to determine cause of death
- 7. To conduct and publish scientific research on the origin, treatment and prevention of special health conditions and diseases affecting humans.
- 8. Provide the services of sub-specialists in the health service centers in the provinces for the prescribed period.
- 9. Determine death and cause of death in accordance with the established criteria.
- 10. Participate in the provision of health services in times of health emergency, national disaster and epidemic.
- 11. Participate in the shaping and further development of the health service and provide technical advice.
- 12. Participate as a medical professional in statutory councils and boards, participate in and advise on technical committees and boards in health care, and boards and councils regulating health care professionals.
- 13. Performing physical examinations to determine the physical and mental condition of the patient requiring health care in a sub-specialist field.

- 14. Obtain additional information from the patient and family members to determine the patient's health status.
- 15. Review medical information compiled by other physicians and health care providers who referred the patient.
- 16. Order medical examinations from a sub-specialist field and continue treatment based on the results of the examinations. and continue to make changes to the treatment based on the outcome of the treatment.
