### **Eligibility Criteria:**

- Master's Degree in Critical Care or in related field. **And**
- PHD or Fellowship in Critical Care or in related field.

### **Scope of Work:**

1. Reviews medical information compiled by patient-referring general medical practitioners and other medical specialists and performs relevant laboratory tests, diagnostic procedures to identify and treat patients requiring critical care.
2. Treatment of patients coming to OPD and admitted
3. Monitor and treat critical care patients admitted in ICU, ER, and other clinical areas
4. Order special tests to diagnose the disease, analyze the results of the tests and continue treatment and make changes to the treatment
5. Monitor the patient's conversion to prescribing and treatment and disease prevention measures
6. Give instructions to the medical officers working in the ward, nurses on what else to do with the care of bedridden patients and explain in detail the condition of the patient at the time to the family members of the patient
7. Research on the causes of special health conditions and diseases faced by patients and research on the treatment and prevention of these diseases and publish in scientific reports.
8. Identify and report communicable diseases requiring critical care to the appropriate authorities
9. Participate in the planning and implementation of public health protection and public awareness programs. and participate in the shaping and further development of the health service system and provide technical advice
10. To provide the services of specialists in the health service in the provinces for the prescribed period. Participate as a medical profession in statutory councils and boards, participate in and advise on technical committees and boards in health care, and boards and councils regulating health care professionals.
11. To conduct special analyzes of the field and to establish the necessary facilities for such analyses.
