2. Review medical information compiled by health care providers with other physicians referring the patient.
3. Order special tests to diagnose the disease and analyze the results of the tests to continue treatment and make necessary changes to the treatment.
4. Prescribe medication and treatment for the patient, medication requests for anesthesia, psychiatric care, rehabilitation and monitor disease prevention measures.
5. Write and record patient medical information and share it with other doctors and other health professionals who need to provide comprehensive treatment to the patient.
6. To assist in research and investigations by sharing information on maternity and deaths and notify diseases with relevant government agencies in fulfillment of legal and technical duties.
