Scope of Work

- Conducting research and analysis related to the specialized field of medicine
- Analysis of the effect of the drug developed in the specialized field.
- Assist in the preparation of medicines for patients receiving treatment in the specialized field.
- Work with other members of the team to ensure that the medication given to patients in the specialized area is the best medication.
- Maintain the quality of care provided to patients in the specialized field and work to improve the quality of life of the patient.
- Provide information about the medication used to treat the disease to the patient, patient caregivers and staff working in the specialized field.
- Conducting necessary inspections at ports to ensure that the drugs imported from the designated area are included in the approved drug list, issuing health clearance to shipments and taking necessary measures to prevent the entry of substandard and unauthorized drugs.
